About Tax Declarations

Let's look at common examples to determine whether a return or report needs to be filed. The requirement to file depends on your individual circumstances. For more information, consult with the Zeimu (Tax) Division in the Naka Ward Office (4F, Counter 43).

No Do you have income this year? (January 1-December 31) No Are taxes withheld from your salary? (*1) Refer to Point! 1) on page 2. Yes No Does your workplace make a year-end adjustment (*2) to your salary? Yes Does your employer submit a 給与支払報告書 No (salary payment report) to the City of Yokohama? If your employer also deducts 所得税 (income tax) and 市民税·県民税 [resident (city and prefecture) tax] from you salary,

Submit a 市民税・県民税申告書 [resident (city and prefecture) tax report] to the Zeimu (Tax) Division in the Naka Ward Office (4F, Counter 43), by post or in person.

Refer to Point! ② on page 2.

Submit your own income tax return (*3) to the tax office. The return can be submitted through the e-Tax system, at your local tax office or by post.

Note: Sole proprietorships or persons with income from two or more sources submit their own income tax return.

Submit a resident (city and prefecture) tax report to the Zeimu (Tax) Division in the Naka Ward Office (4F, Counter 43), by post or in person.

For 2022, the above are submitted between late February-March 15, 2023!

Explanation of Japanese Terms

Tax withholding (源泉徴収 gensen choshu) *1

Your employer calculates the provisional income tax amount according to prescribed methods and deducts that tax amount from your salary in advance. The deducted amount is paid to the tax office by your

in general you don't need to submit your own tax return.

Year-end adjustment (年末調整 nenmatsu chosei) *2

At the end of the year, your employer recalculates the official amount of income tax by adjusting the amount that has already been withheld from your salary based on any applicable deductions such as insurance premiums.

Income tax return (確定申告 kakutei shinkoku) *3

If income tax is not withheld from your salary or you run your own business as a sole proprietor, you must calculate and declare the amount of your income tax. If your employer does not make a year-end adjustment, it means that deductions for insurance (including for National Health Insurance premiums), etc. have not yet been made. Submitting an income tax return with these deductions may change the amount of income tax you pay.

Tax withholding slip (源泉徴収票 gensen choshu hyo) *4 (p.2)

This document shows the amount of salary you received from your employer and the amount of income tax, etc. you paid to the tax office through your employer. Employers are required by law to provide their employees with this document in December or January.

Point!

If you receive a salary, make sure you receive a tax withholding slip (see page 1,*4) from your employer by the end of January. Also be sure to confirm the contents on the slip!

If you have earned salary income, get a tax withholding slip from your employer and make sure to check the following.

- (1) Amount paid
- (2) Amount paid after employment income deductions
- (3) Total amount of income deductions
- (4) Amount withheld at source

Also check information about dependents and social insurance deductions. If anything is unclear, please check with your employer. Also check whether or not your employer has submitted a salary payment report to Yokohama City.

If this salary payment report has not been submitted, you need to submit a resident (city and prefecture) tax report to the *Zeimu* (Tax) Division in the Naka Ward Office (4F, Counter 43), by post or in person between late February and March 15, 2023.

Point!

If you had no income, inform Naka Ward Office of that fact!

If you had no income between January and December 2022, you need to go to the *Zeimu* (Tax) Division in the Naka Ward Office (4F, Counter 43) and submit a resident (city and prefecture) tax report between late February and March 15, 2023.

If you don't submit your report...



You will not be able to get the resident taxation (tax exemption) certificate or tax payment certificate needed to renew your Residence Card.

If you do not file for your dependent family members, the deduction for dependents will not apply.

Don't throw these documents away (examples)

- · Tax withholding slip
- Notice of National Health Insurance premiums, etc. already paid for the year
- Deduction certificates for social insurance premiums and national pension premiums
- · Deduction certificate for life insurance premiums
- · Deduction certificate for earthquake insurance premiums
- Copies of the remittance slips for funds sent to family members overseas and documents related to family relationships

lf you don't submit your report..





A tax exemption certificate cannot be issued and you will be unable to do various welfare-related procedures correctly.

If you are enrolled in National Health Insurance, the insurance premiums cannot be calculated correctly.

Payment of municipal taxes

There are several ways you can pay your Yokohama City taxes! When your payment slips arrive, please pay by the due date shown on each one.

Main Methods of Payment for Individual Resident Taxes and Property Taxes

At a convenience store

Payment slips with a barcode can be paid at a convenience store.



Options for bank/post office payments

- Direct debit: Payments are automatically deducted from a designated account on the due date. Apply to your bank, etc. to arrange direct debit from your account.
- 2. Bring the payment slip to the counter to pay.
- Pay-easy: Using internet banking or an ATM, pay using the Pay-easy option from the menu.



By smartphone

Using an applicable app,* pay by reading the barcode on the payment slip.





Payment can be made through the Yokohama City Tax Payment Site. A system usage fee will be charged according to the payment amount.





When you don't pay by the due date, you will be sent a written demand for payment.

If you still do not pay:

- · Delinquency measures, including asset seizure, will be set in motion.
- The penalty for late payment is calculated beginning the day after the payment deadline.
- · You may not be able to obtain a tax payment certificate.

When you cannot pay due to disaster, illness, etc., please consult with the zeimu (tax) Division.

Inquiries: Zeimu (Tax) Division, Naka Ward Office (4F, Counter 42)

Caution: If you immediately need a tax payment certificate, 1) pay the taxes at a financial institution, 2) get a receipt for the transaction and 3) bring the original receipt to the Zeimu (Tax) Division in the Naka Ward Office (4F, Counter 46).

Tax Certificates

There are three ways to obtain a resident taxation (tax exemption) certificate, tax payment certificate (for individual resident taxes, property taxes).

Apply at the ward office/Administrative Service Counter Bring personal identification and apply at the tax certificate counter in the Naka Ward Office (4F, Counter 46).

Apply by post

Mail the application form with the fee (postal money order or ordinary money order) and a stamped self-addressed envelope. The application form is available on the Yokohama City website.

Apply via your smartphone

Get your My Number Card (*5) ready and apply through the dedicated site.

My Number Card (Individual Number Card)*5 is convenient for obtaining a certificate of taxation

My Number Card can be used for online applications and other administrative procedures. It can also be used as proof of identity.



Vaccinations for seniors before the start of flu season

Seniors and people with weakened immune systems can become seriously ill with the flu. Also, get your flu vaccination to avoid the risk of a double punch from the flu and Covid-19.

Eligibility: Persons aged 65 and above*

Period: Until Dec. 31 (Sat)

Location: Cooperating Yokohama City medical institutions**

Cost: 2,300 yen

■ Beware of tuberculosis

Tuberculosis (TB) is an airborne infection caused by inhalation of the tubercle bacillus, which usually causes inflammation in the lungs. It is said that 1 in 10 infected people will develop the disease. Tuberculosis is not a disease of the past. It is still a serious infectious disease in Japan, where 40 people develop symptoms and 6 people die each day. In 2020, 16 out of every 100,000 people in Naka Ward developed TB. If you have symptoms such as phlegm and cough, mild fever, sense of fatigue, and weight loss that persist for more than two weeks, please visit a medical institution as soon as possible.

Enrolling your child in daycare from April 2023

Daycare centers take care of children when their parents are working, sick, etc. and cannot look after their child at home during the day. Children can be enrolled from 57 days old through pre-school, but the age of the children accepted varies according to facility.

► Applications to enroll from April 2023 Period: Oct. 12 (Wed) – Nov. 2 (Wed)

Note 1: Send by post, postmarked no later than Nov. 2 (Wed).

Note 2: If you applied for FY2022 but were not accepted, you will need to reapply for FY2023.

What is a *Jichikai/Chonaikai* (neighborhood association)?



What is the deduction for medical expenses (医療費控除 iryohi kojo)?

When you spend 100,000 yen or more on medical costs between January 1 and December 31 (5% or more of your total income when your total income is less than 2 million yen), you can claim a deduction for medical expenses on your income tax return. You'll need to file an income tax return to take advantage of any tax reduction or tax refund that may apply.



No, you can't. You need to file a separate income tax return on your own to claim it.

Tell me how to apply

Fill out a 医療費控除の明細書 (medical expense deduction statement), attach it to your tax return, and submit it to the tax office with jurisdiction over the return.

What Does Income Tax Filing Have to Do with Me?

Until recently, I had never really given much thought to filing my income tax return. Tax returns are the company's job, and I thought that all I had to do each year was submit the needed information for my year-end adjustment and pay any taxes according to what was written on the statement I received. As a result, I didn't know much about things like the tax system or the income ceiling for part-time jobs when a spouse wants to remain a dependent for social insurance (health, pension, etc.) reasons.

One day, a senior colleague at work told me, "In the first year you purchase a home, you can't get a tax refund unless you file a tax return for your mortgage deduction." Taking that opportunity, I decided to study how to fill out a tax return. When I searched the Internet with the keyword "kakutei shinkoku" (income tax return), there were more sites than I expected with information on how to fill out a tax return. By studying on my own and filling in each item according to the explanation, I was able to successfully file for the mortgage deduction. Without realizing it, I had come to understand the types of deductions


and the difference between income and taxable income through the process of filing tax returns. I also now understand why part-

time workers are concerned about not exceeding a certain amount of annual income so they can stay as a dependent.

After that, I started telling my friends when I thought they should file their own tax returns. By submitting your own return as necessary, you will gradually come to understand the Japanese income tax system and can receive applicable tax exemptions, and properly pay your taxes/get a tax refund.

People tend to think you don't need to file a tax return when you have no income. But even with zero income, there are still cases when it is better to submit a resident (city and prefecture) tax report to the ward office. So it's important to acquire the correct knowledge beforehand, whether it's just a year-end tax adjustment through your work or submitting an income tax return yourself.

オムライス

Omuraisu (Japanese rice omelet)

An introduction to seasonal events and Japanese culture in terms of food clothing and housing.



An egg omelet over stir-fried rice is classic Japanese soul food called "Omuraisu." It is commonly served in Japanese homes, but each household has its own style of making them. The Japanese term is a combination of the Japanized pronunciation of "omelet" and "rice."

Basic recipe:

- 1. Stir-fry some vegetables you like, such as finely chopped onion and chicken, green peas, etc.
- 2. Add cooked rice to the vegetables and season with ketchup, shape into an oval and transfer to a plate.
- 3. Cook the egg mixture, keeping it thin. Wrap the plated rice in the egg to complete. You can garnish the egg with ketchup, making a picture or words.

Experiment with different combinations to make an omuraisu unique to you!
